### STUDENT DRESS CODE 2021-2022

1. Students shall wear appropriate undergarments. No pull-ups/diapers allowed.
2. Students shall not wear transparent outer garments.
3. Students shall wear solid blue/black/khaki trousers, jeans, joggers, capri pants, wind pants, knee length shorts (no gym/athletic shorts allowed); they may not extend below the hip line.
  - a. Students shall not wear oversized clothing including baggy pants.
  - b. Students shall wear pants at the natural waistline. Students will not be allowed to wear extreme low-rise style jeans/pants.
  - c. Students shall wear bottoms in a manner where no skin is exposed such as holes/frayed areas/tears/cuts, etc.
  - d. Students in PK - 2<sup>nd</sup> grade may wear leggings which are blue or black in color. All other grades will not be allowed to wear leggings or bikers as outer garments.
  - e. Students shall wear belts, if needed, to hold pants in place at the natural waistline.
  - f. Overalls or coverall pants shall not be allowed.
4. Students in PK- 12<sup>th</sup> grade may wear solid blue/black/khaki skirts, jumpers, dresses or shorts that are of knee length or below. No gym/ athletic shorts will be allowed.
5. Students shall not wear trench coats/dusters/oversized jackets.
6. Students shall only wear loose fitting polo style shirts that must be of a sufficient length, but may not wear oversized polo style shirts. Logos and insignias are allowed but can be no greater than 1 inch. No lace-up tops. Polo style shirts may be any color provided it is a solid color.
7. Students shall only wear loose fitting t-shirts that must be of a sufficient length.
  - a. Students may wear Jim Hogg Co. ISD school sponsored spirit t-shirts.
  - b. Theme for all spirit t-shirts must be "Hebbronville Longhorns" only.
  - c. Spirit t-shirts must be solid black, gold, gray or white.
  - d. No outside organization or tribute/recognition sponsored t-shirts allowed.
  - e. All Extra-Curricular Team/Club shirts requires prior approval from administration.
8. Students shall not wear dark glasses inside any school building or during the instructional day unless prescribed by a physician.

9. Student's hair shall be clean and groomed. In addition, students shall not wear distracting hair colors (i.e. blue, green, orange, pink, purple, etc.). Natural color highlights are acceptable. Extreme or distracting hair styles are not permitted such as punk-rock cuts, Mohawks, spiked hair higher than one inch, reversed Mohawks, etc.
10. Students shall not wear sleeveless or cold-shoulder clothing.
11. Students shall not wear hats, beanies, caps or hoods inside any school building unless an activity requires it.
12. Students shall not wear apparel displaying alcoholic or illegal substances, such as tobacco, the occult, religious, violence, death and/or sexually related content, and any other distracting display.
13. Students shall not wear attire that is low-cut or bareback or apparel that exposes the midriff.
14. Students shall have clean-shaven faces and sideburns shall not extend below the earlobe.
15. Acceptable jewelry for students includes only earrings, necklaces, bracelets, watches, and rings. Students shall not wear mouth grills, gauges, spacers, spikes, or tracers, etc. Eyebrow, nose, lip, or other facial piercings/jewelry are prohibited.
16. Students shall not wear attire suggesting gang affiliations.
17. Exposed tattoos shall be covered.
18. Students shall not wear open toe and/or open back, strapless shoes; no steel toe shoes or boots.
19. Specialty attire may be worn on designated days as approved by administration.
20. All dress/grooming is subject to administrator's discretion.
