

Notice of Emergency Meeting

The Board of Trustees Jim Hogg County ISD

A Emergency Meeting of the Board of Trustees of Jim Hogg County ISD will be held July 10, 2020, beginning at 6:00 PM in the Administration Building 210 W. Lucille Hebronville, Texas.

The Administration Board Room will not be open to the Public.

The Board of Trustees of Jim Hogg County Independent School District will convene an **EMERGENCY MEETING** on **Friday, July 10, 2020, at 6:00pm, by Virtual or Telephone Conference**. The notice of this emergency meeting is provided in accordance with the Texas Open Meeting Act, Section 551.045 of the Texas government code, at least one hour before the posted meeting will be convened. This emergency meeting was called because immediate action is required by the Jim Hogg County Independent School District as a result of the reasonably unforeseeable situation created by an extreme increase in COVID-19 infections in Jim Hogg County.

On July 9, 2020 the County Judge described the sudden rise in cases and the increased risks associated with human interaction. Only two days ago, the Texas Commissioner of Education ordered Texas School Districts to provide all district students with in-school instruction if in-school instruction was requested by a parent. This could lead to unsafe numbers of students and adults congregating together. Unsafe gatherings will expand the threat to our community. At this meeting, the Board may deliberate or act on any of the subjects listed on the following agenda. The President may change the order of items listed below for the convenience of the Board.
